

Brian Farrington Memorial Rides

Sunday 10th June, 2018

For many years Brian Farrington organised the Prescot Eagle Road Club Tourist Trials. Sadly, Brian passed away in early February of 2016 after a short illness, just a few weeks after his 68th birthday. We hope that by naming these rides in Brian's memory, it will act as a fitting tribute to a person who gave so much of himself to cycling.

The rides

There is a choice two routes; a relatively flat 54 miler or a hillier 80 mile ride. Both rides start and finish at the Eureka Cyclists' Café, Two Mills (near the junction of the A540 and the A550) and follow the quiet lanes of Cheshire and Deeside wherever possible. The lunch stop for both rides is at Old Ma's coffee shop, which is located in Gatesheath, near Tattenhall, Cheshire.

The entry fee of £10 includes vouchers towards the cost of food and drink at both the lunch stop and at the finish.

CTC and British Cycling members have a minimum of third party insurance coverage. It is advisable that all other riders ensure that they obtain at least third party coverage prior to riding on the public highway.

Closing date for entries: **Monday 4th June 2018**

Please note that entries will not be accepted on the day of the rides and that the Eureka café does not offer any facilities for car parking.
