- 1. Swim Emma asked by email if the wider Committee had any contacts to arrange a Summer Swim Social venue IA said he would check with Canoe and Sailing Club.
- 2. Communications SW fed back that she had not had much success from local media outlets but would continue to progress by sending out copy/info to them.
- 3. Communications/Coaching SW and Ina mentioned if a meeting for potential new coaches was worth arranging. Consensus was that a Zoom meet would be the best way to go.
- 4. Communications SW will look into promoting the Club Committee, in a similar fashion to the Newsletter spotlights we have done recently on our coaching team .
- 5. Communications SW raised the High5 discount which the club have signed up to. IA will send an email out to members advertising the offer the code can not be published on our social media outlets. IA and LJ will be the contacts for the code should anyone request it.
- 6. Coaching IM said 2 people have showed some interest in qualifying as a coach.
- 7. Kit CP will contact Kit team ref. progress a new 2023 season order.
- 8. Welfare AW said no major issues with Welfare although the BTF have said they have a backlog of DBS checks to complete. One Junior prospective coach is waiting on this.

- 12. Captain LJ brought up the loophole regarding our joint Canoe and Sailing Club membership on Nifty. IA/MW were aware of this. IA will contact Dan to see if we can resolve this.
